

**Clinical Policy: Dasatinib (Sprycel)**

**Description**

Dasatinib (Sprycel<sup>®</sup>) is a kinase inhibitor.

**FDA Approved Indication(s)**

Sprycel is indicated for the treatment of:

- Newly diagnosed adults with Philadelphia chromosome positive (Ph<sup>+</sup>) chronic myeloid leukemia (CML) in chronic phase
- Adults with chronic, accelerated, or myeloid or lymphoid blast phase Ph<sup>+</sup> CML with resistance or intolerance to prior therapy including imatinib
- Adults with Ph<sup>+</sup> acute lymphoblastic leukemia (ALL) with resistance or intolerance to prior therapy
- Pediatric patients 1 year of age and older with Ph<sup>+</sup> CML in chronic phase
- Pediatric patients 1 year of age and older with newly diagnosed Ph<sup>+</sup> ALL in combination with chemotherapy

**Policy/Criteria**

*Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.*

It is the policy of health plans affiliated with Centene Corporation<sup>®</sup> that Sprycel is **medically necessary** when the following criteria are met:

**I. Initial Approval Criteria****A. Chronic Myeloid Leukemia and Acute Lymphoblastic Leukemia (must meet all):**

1. Diagnosis of Ph<sup>+</sup> (BCR-ABL1-positive) CML or Ph<sup>+</sup> (BCR-ABL1-positive) ALL;
2. Prescribed by or in consultation with an oncologist or hematologist;
3. Age ≥ 1 year;
4. Member does not have the following mutations: T315I/A, F317L/V/I/C or V299L;
5. One of the following (a or b):
  - a. Member has contraindication, intolerance, or disease progression on imatinib;
  - b. Request is for treatment associated with cancer for a State with regulations against step therapy in certain oncology settings (*see Appendix D*);
6. For brand Sprycel requests, member must use generic dasatinib, if available, unless contraindicated or clinically significant adverse effects are experienced;
7. Request meets one of the following (a, b, or c):\*
  - a. Pediatrics, age < 18 years: Dose does not exceed the weight-based dosing in Section V;

- b. Adults, age  $\geq 18$  years: Dose does not exceed 180 mg per day;
- c. Dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (prescriber must submit supporting evidence).

*\*Prescribed regimen must be FDA-approved or recommended by NCCN*

**Approval duration:**

**Medicaid/HIM** – 6 months

**Commercial** – 12 months or duration of request, whichever is less

**B. Gastrointestinal Stromal Tumor (off-label) (must meet all):**

1. Diagnosis of unresectable, recurrent, progressive, or metastatic gastrointestinal stromal tumor (GIST; a soft tissue sarcoma);
2. Prescribed by or in consultation with an oncologist;
3. Age  $\geq 18$  years;
4. Failure of imatinib (Gleevec<sup>®</sup>) or Ayvakit<sup>™</sup>, unless contraindicated or clinically significant adverse effects are experienced;  
*\*Prior authorization is required for imatinib, Sutent, and Stivarga.*
5. For brand Sprycel requests, member must use generic dasatinib, if available, unless contraindicated or clinically significant adverse effects are experienced;
6. Dose is within FDA maximum limit for any FDA-approved indication or is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (prescriber must submit supporting evidence).\*

*\*Prescribed regimen must be FDA-approved or recommended by NCCN*

**Approval duration:**

**Medicaid/HIM** – 6 months

**Commercial** – 12 months or duration of request, whichever is less

**C. Bone Cancer (off-label) (must meet all):**

1. Diagnosis of metastatic chondrosarcoma or recurrent chordoma;
2. Prescribed by or in consultation with an oncologist;
3. Age  $\geq 13$  years;
4. For chordoma, one of the following (a or b):
  - a. Member has contraindication, intolerance, or disease progression on imatinib;
  - b. Request is for treatment associated with cancer for a State with regulations against step therapy in certain oncology settings (*see Appendix D*);
5. For brand Sprycel requests, member must use generic dasatinib, if available, unless contraindicated or clinically significant adverse effects are experienced;
6. Dose is within FDA maximum limit for any FDA-approved indication or is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (prescriber must submit supporting evidence).\*

*\*Prescribed regimen must be FDA-approved or recommended by NCCN*

**Approval duration:**

**Medicaid/HIM** – 6 months

**Commercial** – 12 months or duration of request, whichever is less

**D. Off-Label Indications (must meet all):**

1. Diagnosis of myeloid/lymphoid neoplasms with eosinophilia (MLNE) and ABL1 rearrangement in chronic phase;

2. Prescribed by or in consultation with an oncologist or hematologist;
3. Age  $\geq$  18 years;
4. One of the following (a or b):
  - a. Member has contraindication, intolerance, or disease progression on imatinib;
  - b. Request is for treatment associated with cancer for a State with regulations against step therapy in certain oncology settings (*see Appendix D*);
5. For brand Sprycel requests, member must use generic dasatinib, if available, unless contraindicated or clinically significant adverse effects are experienced;
6. Dose is within FDA maximum limit for any FDA-approved indication or is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).\*

\*Prescribed regimen must be FDA-approved or recommended by NCCN

**Approval duration:**

**Medicaid/HIM** – 6 months

**Commercial** – 12 months or duration of request, whichever is less

**E. Other diagnoses/indications (must meet 1 or 2):**

1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
  - a. For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.33 for health insurance marketplace, and CP.PMN.255 for Medicaid; or
  - b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.103 for health insurance marketplace, and CP.PMN.16 for Medicaid; or
2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

**II. Continued Approval**

**A. All Indications in Section I (must meet all):**

1. Currently receiving medication via Centene benefit, or documentation supports that member is currently receiving Sprycel for a covered indication and has received this medication for at least 30 days;
2. Member is responding positively to therapy;
3. For brand Sprycel requests, member must use generic dasatinib, if available, unless contraindicated or clinically significant adverse effects are experienced
4. If request is for a dose increase, request meets one of the following (a, b, or c):\*
  - a. Adults age  $\geq$  18 years, bone cancer, or GIST: New dose does not exceed 180 mg per day;

- b. Pediatrics age < 18 years for CML or ALL: New dose does not exceed weight-based dosing in Section V;
- c. New dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).

*\*Prescribed regimen must be FDA-approved or recommended by NCCN*

**Approval duration:**

**Medicaid/HIM** - 6 months

**Commercial** - 12 months or duration of request, whichever is less

**B. Other diagnoses/indications (must meet 1 or 2):**

1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
  - a. For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.33 for health insurance marketplace, and CP.PMN.255 for Medicaid; or
  - b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.103 for health insurance marketplace, and CP.PMN.16 for Medicaid; or
2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

**III. Diagnoses/Indications for which coverage is NOT authorized:**

- A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace and CP.PMN.53 for Medicaid, or evidence of coverage documents.

NV	Yes	Stage 3 and stage 4 cancer patients for a prescription drug to treat the cancer or any symptom thereof of the covered person
OH	Yes	<i>*Applies to HIM requests only*</i> For stage 4 metastatic cancer and associated conditions
