Description

Lacosamide (Vimpat®) is an anticonvulsant.

FDA Approved Indication(s)

Vimpat is indicated:

- For the treatment of partial-onset seizures in patients 1 month of age and older.
- As adjunctive therapy in the treatment of primary generalized tonic-clonic seizures in patients 4 years of age and older.

Policy/Criteria

Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.

It is the policy of health plans affiliated with Centene Corporation[®] that Vimpat is **medically necessary** when the following criteria are met:

I. Initial Approval Criteria

A. Partial-Onset Seizures (must meet all):

- 1. Diagnosis of partial-onset seizures;
- 2. Age ≥ 1 month;
- 3. Failure of two preferred alternatives (*see Appendix B for examples*) unless clinically significant adverse effects are experienced or all are contraindicated;
- 4. If request is for brand Vimpat, member must use generic lacosamide, unless contraindicated or clinically significant adverse effects are experienced;
- 5. Dose does not exceed any of the following (a or b):
 - a. Age \geq 17 years: 400 mg per day;
 - b. Age 1 month to < 17 years (i, ii, iii, or iv):
 - i. Weight \geq 50 kg: 400 mg per day;
 - ii. Weight 30 kg to < 50 kg: 8 mg/kg per day;
 - iii. Weight 6 kg to < 30 kg: 12 mg/kg per day;
 - iv. Weight < 6 kg: 15 mg/kg per day.

Approval duration: 12 months

B. Primary Generalized Tonic-Clonic Seizures (must meet all):

- 1. Diagnosis of primary generalized tonic-clonic seizures;
- 2. Age \geq 4 years;

- 3. Failure of two preferred alternatives (*see Appendix B for examples*) unless clinically significant adverse effects are experienced or all are contraindicated;
- 4. If request is for brand Vimpat, member must use generic lacosamide, unless contraindicated or clinically significant adverse effects are experienced;
- 5. Vimpat will be used as adjunctive therapy;
- 6. Dose does not exceed any of the following (a or b):
 - a. Age \geq 17 years: 400 mg per day;
 - b. Age 4 to < 17 years (i, ii, or iii):
 - i. Weight \geq 50 kg: 400 mg per day;
 - ii. Weight 30 kg to < 50 kg: 8 mg/kg per day;
 - iii. Weight 11 kg to < 30 kg: 12 mg/kg per day.

Approval duration: 12 months

C. Other diagnoses/indications (must meet 1 or 2):

- 1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
 - a. For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business: CP.PMN.255 for Medicaid; or
 - b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.PMN.16 for Medicaid; or
- 2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.PMN.53 for Medicaid.

II. Continued Therapy

A. All Indications in Section I (must meet all):

- 1. Currently receiving medication via Centene benefit, or documentation supports that member is currently receiving Vimpat for seizures and has received this medication for at least 30 days;
- 2. Member is responding positively to therapy;
- 3. If request is for a dose increase, new dose does not exceed any of the following (a or b):
 - a. Age \geq 17 years: 400 mg per day;
 - c. Age 1 month to < 17 years (i, ii, iii, or iv):
 - i. Weight \geq 50 kg: 400 mg per day;
 - ii. Weight 30 kg to < 50 kg: 8 mg/kg per day;
 - iii. Weight 6 kg to < 30 kg: 12 mg/kg per day;
 - iv. Weight < 6 kg: 15 mg/kg per day.

Approval duration: 12 months

B. Other diagnoses/indications (must meet 1 or 2):

- 1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
 - a. For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business:
 CP.PMN.255 for Medicaid; or
 - b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.PMN.16 for Medicaid; or
- 2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.PMN.53 for Medicaid.

III. Diagnoses/Indications for which coverage is NOT authorized:

A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – CP.PMN.53 for Medicaid, or evidence of coverage documents.
